ULBs may expedite complying with OUIDF stipulations.

SWM Status

- Land alienation process is being pursued and a site visit is planned to Jajpur, Vyasanagar, Anandpur and Barbil.
- DPR will be submitted by Consultants by 15th June and tender shall be floated.
 Environmental Clearance shall be followed up.
- Govt. to initiate appointment of an Agency for approval of the DPRs.
